### 1 Information About Us

We are a limited company registered in England and Wales under company number 1232580 and have our registered office at Albion Works, Uttoxeter Road, Longton, Stoke-on-Trent ST3 1PH. Our main trading address is Lymedale Cross, Lower Milehouse Lane, Newcastle-under-Lyme, Staffordshire ST5 9BT.

### 2 Accessing Our Site
